- 2. When the Shooter includes your Vendor Coupon with their Shooter Registration paperwork two things happen:
 - 1) The Shooter is entered into a drawing for a \$50 SASS Mercantile Gift Card; and
 - 2) In exchange for every one of your customized Vendor Coupons we receive YOU will receive a \$2 rebate on your Vendor Registration Fee. (See attached VENDOR REBATE PAYOUT SCALE for detail.)

HERE'S HOW TO MAKE THIS WORK FOR YOU...

- 1. Sign up <u>now</u> to vend Shootout 2013! Complete and mail your Shootout 2013 Vendor Registration and fees per the instructions on the Vendor Registration Form. The sooner you register to vend at Shootout 2013 the more time you'll have to earn your rebate.
- 2. Upon our receipt of your Vendor Registration and fees we will email you a Vendor Coupon customized with your business name.
- 3. **Start promoting Shootout 2013!** Get your customized Vendor Coupon in the hands of Shooters and their shooting friends. Encourage them to register for Shootout 2013 and to send in the Vendor Coupon with their Shooter Registration so they will be entered into the drawing.

VENDOR REGISTRATION FEES & DATES

Early Registration: \$75, Postmarked now through December 2012

Regular Registration: \$100, Postmarked January 2013 through March 22, 2013

ADDITIONAL CONSIDERATIONS:

- 1. One Vendor Coupon is allowed per Shooter Registration (not per each shooter on the registration).
- 2. Vendor Coupons are accepted only [1] with the Shooter Registration, and [2] by the stated Shooter Registration Deadline. No Vendor Coupons will be accepted after the deadline and/or at the event.
- 3. Shooters' Gift Card drawing will be held at Shootout 2013 and is based entirely on Vendor Coupons received with Shooter Registrations with the Shooter present. Cancelled shooters are not eligible for the drawing.
- 4. Vendor may copy and distribute the customized Vendor Coupon as desired.
- 5. Vendor Registration Fees are eligible for rebate according to the VENDOR REBATE PAYOUT SCALE (attached) and only for shooters who attend. Vendor Coupons received but where the shooter cancelled or is a no show are not eligible for the rebate.
- 6. Vendor Rebates will be mailed in the weeks following the close of Shootout 2013.
- 7. Vendors sharing retail space may split the Vendor Registration Fee. All Vendor Coupons received for the shared retail space are applied towards the total rebate but cannot exceed either \$50 or \$75 depending on the amount of the Vendor Registration Fee initially paid. One check will be issued to the first Vendor registering for the shared space. 5 Dogs Creek will not issue more than one Vendor Rebate check per retail space.

VENDOR AGREEMENT

The undersigned, as an authorized representative, is applying to be a Vendor at SHOOTOUT and agrees to the terms and conditions set forth in this agreement:

- 1. No later than March 22, 2013, Vendor agrees to deliver 100% of the Vendor Application Fees, signed AGREEMENT, completed LISTING, completed APPLICATION, and signed RELEASE to Sunshine Kid, 2713 West 155th Street, Gardena, CA 90249. Check payable to "5 Dogs Creek."
- 2. Set up of sales area may begin Sunday, April 28 and must be completed by end of day on Wednesday, May 1.
- 3. Vendor will be open for business by 9:30AM on all match days, starting Thursday, May 2, until 12:00 noon on Sunday, May 5.
- 4. Vendors may begin tear down no earlier than 12:00 noon on Sunday, May 5.
- 5. Vehicles are not allowed in sales area on match days between 7:30AM to 5:30PM, or before 12:00 noon on Sunday, May 5.
- 6. Retail atmosphere: Merchandise must be CAS appropriate; tent must be white/beige canvas; vendors must dress in attire appropriate to the spirit and nature of the event; any music played onsite must be appropriate to the nature of the event.
- 7. Vendor will provide their own power.
- 8. No alcohol will be consumed during the hours that the range is declared hot.
- 9. Replica guns for sale or display will be treated as if they are real firearms and all SASS rules apply.
- 10. Security is not provided and 5 Dogs Creek and all persons associated with hosting the event do not assume liability for lost, stolen or damaged items.
