- 1. Print the attached Vendor Coupon page and customize them by writing your business name at the top of the coupon.
- 2. Distribute your coupons in any way you wish: send them in an email to your distribution list, post them on your website, hand them out to your customers & folks who visit you at upcoming events, or give them to your friends to distribute to their shooting friends. Some Shooters are regular attendees and some folks will be joining us for the first time. Every Shooter is welcome to Shootout!

The goal is for you to get your Vendor Coupons into the hands of Shooters AND encourage them to INCLUDE THE VENDOR COUPON with their 5 Dogs Creek Shootout 2014 SASS California State Championship **Shooter Registration paperwork**.

- 3. When the Shooter includes your Vendor Coupon with their Shooter Registration paperwork two things happen:
 - 1) The Shooter is entered into a Special Shootout drawing; and
 - 2) In exchange for every one of your customized Vendor Coupons that 5 Dogs Creek receives with a shooter registration package YOU will receive a \$2 rebate of your Vendor Registration Fee.

VENDOR REGISTRATION FEES, DATES & MAXIMUM ALLOWABLE REBATE:

Early Registration: \$75, Postmarked now through December 2013,

\$50 maximum allowable rebate

Regular Registration: \$100, Postmarked January 2014 through March 21, 2014

\$76 maximum allowable rebate

ADDITIONAL CONSIDERATIONS:

- 1. One Vendor Coupon is allowed per Shooter Registration.
- 2. Vendor Coupons are accepted only [1] with the Shooter Registration, and [2] by the stated Shooter Registration Deadline. No Vendor Coupons will be accepted after the deadline and/or at the event.
- 3. Shooters' Gift Card drawing will be held during Shootout 2014 and is based entirely on Vendor Coupons received with Shooter Registrations with the Shooter present. Cancelled shooters are not eligible for the drawing.
- 4. Vendor may copy and distribute the Vendor Coupon as desired.
- 5. Vendor Registration Fees are eligible for a rebate of \$2 per Vendor Coupon received and only for shooters who attend. In the event a Vendor Coupon was received but the shooter cancels or is a no show, there will be no rebate for that Vendor Coupon.
- 6. Vendor Rebates will be mailed in the weeks following the close of Shootout 2014.
- 7. Vendors sharing retail space may split the Vendor Registration Fee. All Vendor Coupons received for the shared retail space are applied towards the total rebate but cannot exceed either \$50 or \$76 depending on the amount of the Vendor Registration Fee initially paid. One check will be issued to the first Vendor registering for the shared space. 5 Dogs Creek will not issue more than one Vendor Rebate check per retail space.

- 2. I will inspect all equipment and firearms for defects prior to and during use. If defects are noted, I will not use it and I will report the condition to a staff member of the club.
- 3. I expressly agree and promise to accept and assume all of the risks existing in this activity. My participation in this activity is purely voluntary and I elect to participate in spite of the risks.
- 4. - No later than March 21, 2014, Vendor agrees to deliver 100% of the Vendor Application Fees, signed AGREEMENT, completed LISTING, completed APPLICATION, and signed RELEASE to Sunshine Kid Check payable to "5 Dogs Creek."
- 2. Set up of sales area may begin Sunday, April 27 and must be completed by end of day on Wednesday, April 30.
- 3. Vendor will be open for business by 9:30AM on all match days, starting Thursday, May 1, until 12:00 noon on Sunday, May 4.
- 4. Vendors may begin tear down no earlier than 12:00 noon on Sunday, May 4.
- 5. Vehicles are not allowed in sales area on match days between 7:30AM to 5:30PM, or before 12:00 noon on Sunday, May 4.
- 6. Retail atmosphere: Merchandise must be CAS appropriate; tent must be white/beige canvas; vendors must dress in attire appropriate to the spirit and nature of the event; any music played onsite must be appropriate to the nature of the event.
- 7. Vendor will provide their own power.
